OVERVIEW Diet and physical activity are two of the most effective ways to manage disease and ensure good health as people age. The USDA and United States Department of Health and Human Services have jointly developed Dietary Guidelines. All federal and state governmental agencies use these guidelines when developing nutrition programs. Nutrition educators, nutritionists, and health care providers also use these guidelines when providing care. Unfortunately, many people, especially the elderly, aren t aware of basic dietary recommendations and requirements. Sometimes, even if they are aware, they don t follow the guidelines for any number of reasons. That is where the aide plays an important role. Home health aides can encourage patients to improve their health by practicing good nutrition and getting adequate physical activity. This in-service outlines the **USDA** 2005 Dietary Guidelines and the MyPyramid plan, and offers techniques for supporting patient dietary compliance.
